We collectively bargain with the University of Oregon which occurs every three years. Bargaining is conducted by a panel of university faculty and University of Oregon representatives. Preparing and engaging in collective bargaining constitutes approximately 50% of the union's activities.

Enforcement of the Collective Bargaining Agreement is an ongoing process which takes up 35% of union activities including the elected group of faculty members who serve on the Executive Council and meet monthly at a minimum.

Other activities include working to improve education at the University of Oregon. Various faculty meetings throughout the year to discuss how education can be bettered at the university account for approximately 10% of the union activity. The remaining activity consists of our work to align with other organizations to improve working conditions for all working Oregonians.
