30	Section 2. The University shall provide all reasonable assistance to employees in securing
31	federal student loan forgiveness, where applicable.
32	
33	Section 3. Bargaining unit faculty members who are using the tuition discount for the
34	undergraduate education of a dependent child will be entitled to a second, concurrent tuition
35	discount for a dependent child to attend undergraduate programs at the University of Oregon.
36	The terms, conditions, eligibility requirements, and discount available applicable to this
37	additional tuition discount will be the same as the terms, conditions, eligibility requirements
38 39	and discount available under the tuition discount program. If both parents of a dependent child are bargaining unit faculty members, a full tuition waiver will be granted for up to 16 credits
39 40	per term. Faculty members who have worked for the University of Oregon for 20 years or
40 41	more, but have since retired or left employment in good standing, will remain eligible for a
42	tuition discount for the undergraduate education of one dependent child for up to 16 credits per
43	term. No undergraduate or exchange/study abroad programs shall be considered an excluded
44	program. The tuition discount shall not be less than 70 percent of the resident undergraduate
45	tuition for bargaining unit faculty members.
